**Rin Grand Hotel
Bucharest – Romania**

1. Welcome Speech of the President

The President opened the Meeting at 09.00 am and welcomed all present. She expressed the wish that this Assembly, as always, would be a meeting where participants show mutual respect, are able to compromise and to make decisions for the benefit of the cat. Then she announced that it was her sad duty to inform the Assembly that four well-known FIFe (former) commission members, honorary judges and all round judges passed away since the last General Assembly. Mr Bohumír Mahelka (CZ) long-year member of the FIFe Disciplinary Commission and an Honorary FIFe All-Breed Judge, Mrs Jitka Kytlerová (CZ) former member of the FIFe Judges Commission and an Honorary FIFe All-Breed Judge, Mrs Maria Cristina Kowalczyk (IT), FIFe All-Breed Judge and Mr Jorge Flechter (AR), FIFe All-Breed Judge. These colleagues and friends would be sorely missed. She asked all those present to observe one minute of silence. Lux Cat Club-FFL (LU) had submitted a written request for secret voting for the duration of the entire General Assembly. This request is attached to the Minutes as **Annex 1**.

For the cats of all group judged breeds, white cats (w) and cats with a high grade of white (01 - 02), the code for eye colour must be included in the full EMS code of the cat.
This change is valid for ~~all white~~ cats registered from 01.01.2012.

Cats registered before 01.01.2012 may keep their EMS code “w” without a code for eye colour without being downgraded to an “x”-variety.

Proposals 1 of ČSCH-SCHK (CZ) - Application to accept the colours Cinnamon (o) and Fawn (p) in the BRI

With reference to articles 10.2 and 10.3 of the FIFe Breeding & Registration Rules, we apply for the acceptance of **cinnamon** and **fawn** as fully recognised colours of the BRI and this in all existing colour varieties to be included in the General Part, BRI standard and EMS List, as follows:

Proposal 2 of ČSCH-SCHK (CZ) - Application to accept Golden (y) in the BML (changed)

With reference to articles 10.2 and 10.3 of the FIFe Breeding & Registration Rules, we apply for the acceptance of **golden** as a fully recognised variety of the BML, in all existing varieties to be included in the General Part, BML standard and EMS List. We suggest creating 2 new groups:

Group 3 - Non-Orange Golden and Group 4 -Orange Golden

To this end, the following changes & additions must be made to the BML standard, pgs 25 & 27:

Page 25 of the BML Standard – coat colour:

Ground colour: pure silver-white, **or warm golden**, shaded and shell in the recognized orange and non-orange colour varieties. For colour varieties, refer to the table below.

Page 27 of the BML Standard - Recognized colour varieties

All recognized BML are silver **or golden** shaded or shell

GROUP I: NON-ORANGE SILVER (rest remains unchanged)

GROUP II: ORANGE SILVER (rest remains unchanged)

GROUP III: NON-ORANGE GOLDEN

- **Burmese cats used in breeding must have a DNA-test for GM2 gangliosidosis, unless both parents are proven to be free from GM2 gangliosidosis.**
- **These breeding principles are to be followed:**
 - **GM2-free x GM2-free**
 - **GM2-free x GM2-carrier**
- **The cats that need testing according to this rule must be identifiable by microchip or tattoo.**
- **The breeder must inform buyers of Burmese cats about the GM2 gangliosidosis-disease and the registration policy.**
- **A certified veterinarian certificate regarding the GM2 gangliosidosis-status must be attached to the pedigree.**

Proposal 1 of NRR (NO): Article 6.15 - Norwegian Forest Cats (NFO) - (Reworded)

Norwegian Forest Cats (NFO) used for breeding shall be DNA tested ~~at a veterinary~~ for the GBE-1 gene (GSD IV - glycogen storage disease), unless both parents of the breeding cat are proven not to be carriers of GSD IV. Cats to be tested after this rule must be identifiable by microchip or tattoo, and the microchip or tattoo ID number shall follow the test documentation ~~from the veterinarian~~ to the laboratory and be clearly stated on the test result certificate. The following breeding principles must be observed: carriers must not be mated with carriers. ~~Brooders (sellers) must inform buyers of Norwegian Forest Cats about the GSD IV disease and the registration requirements.~~ A valid veterinary certificate regarding GBE-1 status shall accompany the cat's pedigree.

Proposal 1 from the BRC – articles 3.6.2, 6.4, 8.1 & 8.4: deletion of the possibility for cats suffering from osteochondrodysplasia to be recognised by FIFe

Article 3.6.2 - Genetic diseases – delete indicated text:

The FIFe will not recognise any breed of cats showing as a breed characteristic:

- osteochondrodysplasia:
an autosomal dominant gene causing progressive joint, bone and cartilage deformity (for example the Scottish Fold) until thorough medical and scientific research proves the unoffending character of the mutation. Until this research is done, it is not allowed to show these cats at any FIFe show.

Article 6.4 - BRI (British) – insert and delete indicated text:

No progeny of **cats suffering from osteochondrodysplasia (see article 3.6.2), regardless of ear-type**, Scottish Fold with straight ears (SFL non * 71 / SFS non * 71) may be registered as a BRI (see article 8.4).

Article 8.1 - List of non-recognised breeds with preliminary abbreviations – delete codes:

SFL non *	Scottish Fold Longhair
SFS non *	Scottish Fold Shorthair

Article 8.4 - change title and replace current text by:

8.4 Cats suffering from osteochondrodysplasia SFL non / SFS non (Scottish Fold) FIFe will not recognise nor create an EMS-code for cats suffering from osteochondrodysplasia (see article 3.6.2).

No cat suffering from osteochondrodysplasia is allowed for breeding.

No cats suffering from osteochondrodysplasia, or with such a cat in its ancestry, can be registered with FIFe or be exhibited at a FIFe show.

From 01.01.2012, the preliminary abbreviations for Scottish Fold (“SFL non” and “SFS non”) are deleted from the list in article 8.1 and cannot be re-created.

Proposal 3 from the BRC – article 4.2: clarification of the requirements for registration in the LO

The **LO register** contains cats that

- belong to a breed (for preliminary recognised breed) **fully** recognised by FIFe (see article 6.1 and 7.4) and
- have a recognised colour variety for the actual breed (see the EMS-list) and

- have a pedigree of pure breeding (i.e. **a recognised colour variety** of the same breed or sister breed) of at least 3 generations prior to the actual cat **and**
- **have the information available as laid down in article 4.5.**

Proposal 4 from the BRC – article 5.1.1: addition for registration of cats without a cattery name (Reworded)

To register cats in a pedigree book the breeder must have a cattery name registered in the FIFe Book of Cattery Names. An exception can be granted by the FIFe Member for no more than two litters bred by an individual breeder.

~~*If a cat is registered without a cattery name, the format of its name must be (Country code) + (Abbreviation of FIFe Member) + (Year + an ongoing number of registration) + (Name of cat in one word). Example: DK FD 12001 Mister.*~~

The EMS codes “dt” and “et” may be used to register the genotype of red/cream progeny from two amber cats together with their phenotype “d” respectively “e” in brackets, in accordance with article 5.1.1. The EMS codes “dt” and “et” may only be used for registration purposes.

Proposal 7 from the BRC – articles 6.1.1 & 6.1.2: definition of sister breeds and “pure breeding” (Reworded)

6.1.1 Sister breeds

Sister breeds are breeds, which share the same standards except for coat length and/or pattern. **For recognised breeds, sister breeds** and can be inter-mated without permission, **except if indicated otherwise in this chapter.**

6.1.2 Pure breeding

A cat is considered “pure bred” when its pedigree shows ancestors in a recognised colour variety for the same breed or sister breed in at least 3 generations prior to the actual cat. This definition also applies to preliminary recognised breeds (see article 7.1) ~~and non-recognised breeds (see article 8.1).~~

Remarks: Rename current article 6.1.2 into 6.1.3.
Therefore, the line in article 4.2 must be changed to a reference to article 6.1.2.

Proposal 8 from the BRC – chapter 7 - addition of the status of a preliminary recognised breed when full recognition is not granted

If full recognition is not obtained before the period for preliminary recognition has expired:

- **the breed with preliminary recognition will automatically be transferred to the list of non-recognised breeds with their preliminary abbreviations in article 8.1 and the EMS code will be followed by a “non”**
- **the rules regarding the breed will be transferred to chapter 8**
- **registration of cats born and preliminary titles achieved during the Preliminary Recognition phase will remain as they are**
- **cats born after the Preliminary Recognition phase must be registered in the RIEX register and “non” added after the breed abbreviation to indicate that this is now a non-recognised breed.**

*The FIFe Member must grant permission before breeding with a non-recognised breed with a preliminary abbreviation. The application for such breeding must contain at least information on the breed, a full breeding programme, the intended standard and scale of points together with the philosophy of the breed. **If the FIFe Member has granted this permission**, the progeny of such a mating **breeding** may be registered in the RIEX register, provided the FIFe Member has granted permission for the mating breeding according to article 8.1.*
